



## REGISTERED NURSE and ARNP's Continuing Education Requirements Rule 64B9-5, F.A.C.

### TOTAL REQUIRED HOURS FOR RN's and ARNP's - 24

REQUIRED SUBJECT AREA	REQUIRED NUMBER OF HOURS	IMPORTANT INFORMATION
<b>General Hours</b>	22	Can be live or homestudy
<b>Medical Error</b>	2	May be live or homestudy; Must be board approved. Approved courses are listed in cebroker
<b>Laws and Rules (new requirement)</b>	2	Laws and Rules will be due beginning with the biennium expiring 2015. The biennium in which the Laws and Rules course is due your general hours will total 20 (licensees expiring in 2014 are not required to complete laws and rules until their 2016 renewal)
<b>Domestic Violence</b>	2	Domestic Violence is required every third biennium and the hours are <b>in addition to the 24 hours</b> required for renewal

<b>First Renewal Requirements</b>	<ul style="list-style-type: none"> <li>• Practitioners initially licensed by examination during the current biennium are exempt from the general CEU requirements for the first renewal. Those practitioners must complete 2 hours of medical error, 2 laws and rules and 1 hour of HIV/AIDS</li> <li>• Practitioners intially licensed by endorsement during the current biennium and took the exam in another state within the biennium are exempt from general CEU hours. Those practitioners must complete 2 hours of medical error, 2 hours laws and rules and 1 hour of HIV/AIDS</li> <li>• Practitioners that do not qualify for the exemption in their first renewal must complete 2 hour for per month or partial month remaining in the biennium from the date the license was issued. These hours must include 2 hours of medical error, 2 hours laws and rules and 1 hour of HIV/AIDS</li> </ul>
<b>Board Rule Approved Providers</b>	<ul style="list-style-type: none"> <li>• Florida Board approved courses for Nurses can be found at <a href="http://www.cebroker.com">www.cebroker.com</a></li> <li>• Course approved by a state or national organization empowered to accredit nursing continuing education is acceptable</li> </ul>
